Decision as to the eligibility of the Candidates, the Placement of a Star and the Inscription on the Star, rests with the New Las Vegas Walk of Stars Board of Directors.

Requirements and guidelines are set forth in the Selection Criteria for the New Las Vegas Walk of Stars form. If approved, a tax-free donation of \$30,000 must be deposited 90 days prior to the installation. This is a Non-Profit 501 (c) 3 Organization, and the donation is non-refundable.

## SELECTION CRITERIA FOR THE NEW LAS VEGAS WALK OF STARS

The New Las Vegas Walk of Stars Board of Directors has adopted the following Star Dedication Criteria, which will serve as a guideline to honor deserving personalities by placing a Star on the sidewalks of Las Vegas in Clark County, Nevada.

1. The designated location is on Las Vegas Boulevard from Sahara Avenue to Russell Avenue.
2. Honorees must have worked in Las Vegas and contributed to the charm, worldwide prominence and name recognition of Las Vegas.
3. The following persons will be considered Candidates:
  - a) **Show Business:** Persons who have distinguished themselves as Actors, Producers, Directors, Playwrights, Cinematographers, Musicians or Comedians, either on Stage, Radio, Film or Television, as well as persons who have otherwise become prominent in the Field of Entertainment and have greatly contributed to the worldwide prominence of Las Vegas.
  - b) **Literary Persons:** Such as Authors, Playwrights and Screen Writers who have penned Literary Works of considerable distinction and have achieved National or International recognition.
  - c) **Pioneers and Civic:** A Star may be awarded to local persons prominently and historically linked to the development of Las Vegas, such as the Early Settlers and Civic Personalities with significant Historical achievement and have distinguished themselves in the service to the community.
  - d) **Humanitarians:** A Star may be awarded to persons who have greatly distinguished themselves in the service to their fellow man by enduring and selfless contributions to charitable causes within the community.
  - e) **Sports:** Athletes, Coaches and Owners who have excelled in their respective field of sports and have greatly contributed to the worldwide prominence of Las Vegas.
  - f) **Military:** Congressional Medal Awardees, only.
4. The inscriptions on the Stars must be relevant to the Honoree's Field of Achievement.
5. A tax-free donation of \$30,000 is required for each Star. Checks should be made payable to the New Las Vegas Walk of Stars, a dba of The Motion Picture Hall of Fame Foundation, a 501(c) 3 non-profit Corporation, Tax ID #71-0946230, reported as such to the IRS, and is non-refundable.

This donation includes all expenses related to the manufacturing, shipping and installation of the Star, a County Proclamation and a framed Walk of Stars Replica.
6. Any expenses exceeding the above mentioned items, such as special pomp and circumstances, bands, chairs, street closures, special security, cocktail reception, etc., shall be borne by the Sponsor and is subject to approval by the Board of Directors. The New Las Vegas Walk of Stars Committee will assist in the arranging and handling of these special particulars, if so requested.
7. All business aspects of the New Las Vegas Walk of Stars are administered by the Board of Directors, and in matters relating to the New Las Vegas Walk of Stars, are final.
8. The New Las Vegas Walk of Stars, a dba of The Motion Picture Hall of Fame Foundation, a non-profit public benefit corporation, is an equal opportunity organization, is non-discriminating in its evaluation and confirmation of Star Candidates. Race, creed, religion or ethnic heritages of a Candidate are absolute non-factors. Candidates are solely selected on achievements within their endeavors and contributions to the community.

## WAIVER OF DONOR FOR THE NEW LAS VEGAS WALK OF STARS

1. THE NEW LAS VEGAS WALK OF STARS PROGRAM: Clark County, a corporation (herein "County") and The New Las Vegas Walk of Stars (herein "NLVWOS") a dba of The Motion Picture Hall of Fame Foundation, a 501(C3) non- profit public benefit corporation, Tax ID #71-0946230, have agreed that the Contractor shall install a Star in the public right of way to honor prominent personalities associated with the NLVWOS.

However, the County is concerned with liability to pedestrians and must retain the right to require proper care of the Stars and the right to require removal and/or relocation of the Stars, if necessary, without incurring liability to the donors. Therefore, the County's approval of the Stars has been based on receiving: (a) An irrevocable offer to dedicate to Clark County as a gift all Stars installed in the public right of way, and (b) The written waiver and release of any and all donors or contributors of any rights, title or interest in the Stars.

2. WAIVER WITH RESPECT TO MODIFICATION OR REMOVAL: The Donor, agents, heirs, successors and assigns, hereby waive any and all rights, title, causes of action or interest in the Star towards which the tax free contribution was made.

Donor understands that NLVWOS and/or the County have the right to alter, relocate or remove the Star at any time, and Donor waives any and all causes of action, damages, rights to receive any notice and/or compensation, or to object to the alteration, relocation, removal or destruction of the Star.

3. INDEMNIFICATION OF DONOR: The NLVWOS agrees to indemnify the donor, agents, heirs, successors and assigns against, and will save and hold harmless from, any and all actions, suits, claims, damages to persons or property, losses, costs, penalties, obligations, errors, omissions or liabilities, including paying any legal costs, attorneys' fees, or paying any judgment (herein "claims or liabilities") that may be asserted or claimed by any person, firm or entity arising out of or in connection with the negligent acts or omissions of the NLVWOS hereunder.

4. WAIVER OF RIGHT TO SUE: The Donor, its heirs, successors and assigns hereby waive any right to sue the NLVWOS or Clark County for breach of any written or oral representation with respect to the Walk of Stars Program including, but not limited to, the Revocable License and Maintenance Agreement, except that Donor shall not waive any right to enforce the indemnification covenant of NLVWOS contained in Section 3 above.

5. ARBITRATION: Any dispute arising out of or in connection with this Agreement shall be submitted to arbitration in accordance with the rules and regulations of the American Arbitration Association.
